A. We agree to pay the entire amount of INR 5,66,400 in favour of ‘STEM Learning Pvt Ltd’ upon completion of delivery and installation as mentioned in the PO.

B. Delivery and installation will be completed within 45 days of issue of this PO.

C. We also agree that the price in this Purchase Order shall be valid only for 6 months from the date of signing. If payments not made within 3 months from the date of issue of this PO then STEM Learning Pvt Ltd shall be at liberty to revise the price.

D. We agree to use the equipment/materials as recommended on operation manual ensuring proper compliance. It will not be serviced by any unauthorised person. The defective spare part after service will be property of STEM. STEM is supplier and Service liability will be on the manufacturing company.

E. We agree that there are no verbal or other commitments between us. All legal matters will be subject to Guwahati jurisdiction only.

F. We understand that STEM will not be liable for any loss or damage due to delay in manufacture, delivery or service due to any condition beyond the company’s reasonable control, including but not limited to compliance with any regulations, order or instruction of any central or state governments or any departments or agency thereof, acts of God, acts of omission of the purchaser, fire, strike, factory shut down or alterations, embargoes, war, riots, flood, delay in transport, labour trouble or any delay resulting such cause, shall extend delivery date correspondingly. This delay also includes on account of procurement of bought-out items.
