LETTER OF UNDERTAKING

This is an INDENTURE of Letter of Undertaking (hereinafter referred to as, 'LOU') signed on the 6th day of December 2023 at Mumbai by Seva Sahayog Foundation (SSF) NGO, having their registered office at Plot No 75, Tulshibagwale Colony, Sahakar Nagar No 2, Parvati, Pune Maharashtra 411009.

Represented by Mr. Dilip Moghe, Director who has been duly authorized to enter this LOU on behalf of Seva Sahayog Foundation (letter of authorization to be attached).

WHEREAS Seva Sahayog Foundation has sought financial support from General Insurance Corporation of India (hereinafter referred to as, 'GIC Re') towards installation of STEM (Science, Technology, Engineering, Mathematics) learning - Mini Science Centre at 25 schools in aspirational district of Jharkhand. which has been approved by GIC Re and entered a LOU for the 'Project' specified therein.

AND WHEREAS the said request which has been approved by GIC Re upon verification and to its satisfaction vide note dated 23rd October 2023 and approval has been communicated to Seva Sahayog Foundation vide letter dated 04th December 2023.

AND WHEREAS the total grant amount requested is **INR 1,34,74,125** /- (Rupees One Crore Thirty-Four Lakhs Seventy-Four Thousand One Hundred and Twenty-Five Only) (hereinafter "the Grant Amount").

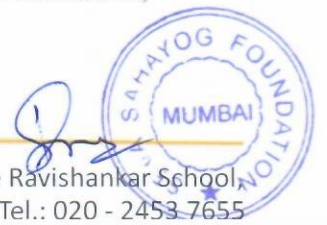
NOW THEREFORE, in consideration of GIC Re agreeing to the Grant Amount, vide this LOU Seva Sahayog Foundation undertakes the following:

Project Financials:

Cost of Mini Science Centre+ Training of Teachers+ Monitoring and Evaluation + Annual Maintenance Contract + Infrastructure + NGO Admin Cost for 1 School is Rs.5,38,965.00 only.

Total Cost of 25 Schools: Rs.5,38,965 x 25= Rs.**1,34,74,125** only.

1. GIC Re will contribute an amount not exceeding Rs.**1,34,74,125** /- to Seva Sahayog Foundation.
2. The payment will be made in 2 equal installments.
3. The first instalment of Rs. 67,37,062.50 /- will be an advance.
4. The balance instalment will be released on submission of the following.
 - a. utilization certificate issued by statutory auditors/CA Seva Sahayog Foundation,
 - b. statement of accounts issued by statutory auditors/CA of Seva Sahayog Foundation,
 - c. Submission of 80G certificate
 - d. Complete Mini Science Centre Installation report for all 25 Schools

- e. Certified copies of invoices and bills for the procured items, including GST charges. These documents help ensure that all expenses are properly accounted for and that the funds allocated for the Mini Science Centre (MSC) project are used appropriately.
5. GIC Re logo will be displayed at Models, Backdrop and at the lab location of Mini Science Centre (MSC) of 25 schools.
 6. Inspection visit may be organised.
 7. Third party impact assessment may be conducted at the end of the project timeline.
 8. GIC Re officials will visit the Centres post completion of installation at the 25 schools. A report on the implementation will be submitted to the CSR Committee of the GIC Re Board.

Seva Sahayog Foundation will provide regular information/details of activities and expenses to GIC Re. Seva Sahayog Foundation also undertakes to provide relevant information as required under the rules of section 80G of the Income Tax Act, 1961. Seva Sahayog Foundation will issue to GIC Re separately a duly Signed and Stamped Receipt under section 80G of Income Tax Act, 1961. Seva Sahayog Foundation will issue a receipt to GIC Re separately for donation amount received.
