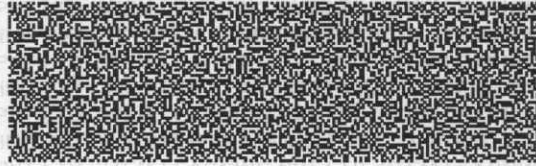

AND

AHP Apparel Pvt. Ltd is a company incorporated under the Companies Act 1956 and has its office at its **Registered Office at F-88 Okhla Industrial Area Phase - 1 New Delhi- 110020** and a corporate office, amongst other places at Industrial Plot no. 1, Sector-28, Faridabad - 121008 and having 02 production units in Sector 28, Faridabad, Haryana- 121008 represented by its authorized signatory **Mr. Deepak Rautela, Associate Vice President - OD** (hereinafter referred as AHP Apparel) which expression shall unless repugnant to the context or meaning thereof, shall mean and include its successors and permitted assigns) on the **OTHER PART**.

The Service Provider and the AHP Apparel shall be hereinafter collectively referred to as the "Parties" and individually as the "Party"

This **service agreement** was made based on the discussion and agreed by both parties to provide the service

(herein referred to as Project) **W.E.F 06/02/2024 to 31/03/2025, project duration will be for 1 year and 02 months**. The AHP Apparel and the STEM Team, (collectively called Parties to the service agreement) are in good faith coming together to execute this service agreement. This service agreement creates a legally binding obligation between both parties in connection with the subject matter of this service agreement, until or unless any further documents are executed to give effect to such obligations.

1. SCOPE AND DELIVERABLES OF THE PROJECT

STEM Learning was conceptualized with the aim to inculcate basic concepts of Science, Technology, Engineering, and Mathematics at the school level, thereby encouraging the inclination of students/learners towards science and technology. Models designed by the STEM team to help students identify and experience the actual concepts that they learn from textbooks making it more practical in approach. STEM believes that school education can't be only visual or audio, but it is important for the children to practically feel the products and experience them. With this vision, STEM has customized 80 models based on 130+ concepts of Science and Maths, in addition to 105 chemistry experiment models for better learning and understanding of the concepts.

Under its Corporate Social Responsibility program guided by Schedule VII of the Companies Act 2013, the AHP Apparel and the STEM Team agreed to commence a STEM Learning project in 01 government school. The Mini Science Centre will be set up and training sessions will be organized for the students and teachers in a Government Senior Secondary Schools (hereinafter referred to as GSSS) in the state of Haryana. The details of the school are as follows-

2. ROLES AND RESPONSIBILITIES OF THE PARTIES

2.1 ROLE OF STEM LEARNING PVT. LTD.

- Setting up a mini science Centre by providing all the above-mentioned models
- Assured power supply
- Availability of tables to display exhibits
- Instruction to selected school headmasters to provide acknowledgment letters after the centre has been established
- The STEM Team must put out the banner and awareness handouts/ communication materials about the project during the activities
- Not make any financial commitment on behalf of the AHP Apparel, nor shall take loans or create any other financial liability binding the AHP Apparel under this service agreement.
- Mini Science Centre setup / Installation must be CHILD-FRIENDLY LEARNING SPACE
- Whenever there is damage in the provided models, the STEM team must replace them and do the annual maintenance for the same

2.2. ROLE OF AHP Apparel

- The AHP Apparel team from the respective units must coordinate with the STEM team and ensure their activities and training programs in the schools
- The AHP Apparel will be transferring the funds to STEM Learning's Pvt Ltd and ensure that the activities are delivered, and funds are utilized for the approved plans
- The AHP Apparel team will visit the school for strict monitoring the task periodically and may suggest changes based on the observations and requirements



3. AGREEMENT TERM AND TERMINATION

3.1. This service agreement commences on 06th February 2024 and continues to be in full force and effect till 31st March 2025, unless terminated as specified below

3.2. This service agreement may be terminated as follows:


- By either service provider upon providing a written notice of 30 days prior written notice to the AHP Apparel; or
- By the AHP Apparel, in the event of a material breach of any provision hereof committed by the service provider or by providing 30 days written notice to the Service provider with the reasons of termination stated thereunder: or
- If there are any additions/deletions to these services, they have to be taken prior to Email / written approval from the AHP Apparel team

4. FINANCIAL PLAN

The Parties have agreed to certain conditions in relation to financial planning and assistance for completing the services. The budget allocated is Rs. 5,52,240/- (Five Lacs, Fifty Two Thousand, Two Hundred and Forty only) The 1st installment will be released after the signing of the MOU which is Rs. 2,76,120/- (Two Lakhs Seventy Six Thousand and One Hundred & Twenty only) and 2nd installation will be released after installation of Mini Science Centres and installation reports which is Rs. 2,76,120/- (Two Lakhs, Seventy Six Thousand and One Twenty only).

5. GOVERNING LAW AND DISPUTE RESOLUTION

Any dispute or difference arising between the Parties out of or in connection with this Agreement shall be settled amicably and resolved by negotiations. In the unlikely event of failure of negotiations within 15 days from the date of the written notice of the details of the issue in dispute, such disputes shall be referred to Arbitration as per the Indian Arbitration and Conciliation Act, 1996 and the rules made therein and as amended from time to time. The place of Arbitration shall be Bangalore and the language shall be English (UK):




This Agreement shall be governed by Indian Law and the courts at [Faridabad] shall have exclusive jurisdiction to adjudicate any disputes under this Agreement.
