NOW THE PARTIES HEREBY AGREE AS FOLLOWS

1. APPOINTMENT OF THE CONSULTANT

4. Govt Model Senior Secondary School, Faridabad
5. Swami Vivekananda Shiksha Niketan, Noida
6. Vidya School, Gurugram

2.1.1 Roll out plan

The Consultant will discuss and finalize the plan for the roll-out along with Concern and the School authorities.

2.1.2 Installation of MSC in School

Facilitate to obtain permission from concern authorities (Government or local key person if required) for the implementation of the program. Installations of 80 models at Schools need to be done along with ensuring infrastructure support on site from school in terms of power supply, furniture, space and cleanliness.

2.1.3 Teacher's training

Organizing series of two training program for teachers:

1st training for teachers will be conducted in the month of February 2024 at project level (Beginning of project) focusing on using various models for teaching students/ methodology / motivation / events organized every year under the program and expected role of teachers.

2nd training for teachers will be conducted in the month of July 2024 to discuss issues at school level focusing on problem solving and encouraging the use of MSC of all the 80 models to the teachers identify the challenges faced and discuss.

2.1.4 Monitoring & Evaluation

- Undertake M&E activities for baseline data.
- M&E Officers visit twice year.
- Reporting maximum usage of MSC by teachers.
- Reporting maximum usage of MSC and models by Students
- Pre Evaluation: in the first month
- Final Evaluation: at the end of the year

2.1.5 Maintenance –

- Maintenance is for 3 years.



- 1st year maintenance from 1st February, 2024 to 31st January, 2025, inclusive in the set up cost from the date of installation that will ensure the following maintenance like cleaning, oiling and checking the models in 6 schools in Delhi.
- 2nd year maintenance from 1st February, 2025 to 31st January, 2026.
- 3rd year maintenance from 1st February, 2026 to 31st January, 2027.
- Under maintenance, models will be repaired for damages such as LED repairing, broken threads etc.
- However, if the model is completely broken due to mishandling, it will not fall under the scope of maintenance.
- Repairing will be done within 15 working days from the day of raised query

3. TERM

Unless terminated earlier in accordance with the terms contained herein, the term of this Agreement commences on **1st February 2024** and will terminate on **31st March 2025** ("Term")

3A. FEES, PAYMENTS AND SETTLEMENTS:

A total amount of **INR 33, 25,800 /-** will be paid for the Consultancy services for setting up of STEM labs in schools in Delhi.

A total of **INR 33,25,800/-** will be paid before the end of March 2024 on receipt of a consent letter from STEM confirming the timeline of the installation, the teacher's training program period and the submission of completion letter along with a detailed report.
